(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto TRAVELERS REST FEDERAL SAVINGS AND LOAN ASSOCIATION OF Travelers Rest, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated

herein by reference, in the sum of

TWENTY FOUR THOUSAND and no/100

fourths

DOLLARS (\$ 24,000.00), with interest thereon from date at the rate of eight and three-per centum per annum, said principal and interest to be paid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, and

WHEREAS, the unpaid balance of said debt or debts, if not sooner paid, shall be due and payable.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does hereby grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Paris Mountain Township, containing 2.04 acres, more or less, as shown on plat of W.F. Shivers, recorded in the R.M.C. Office for Greenville County in plat book 4-U, page 34, and having the following metes and bounds, to-wit:

Beginning at an iron pin in the center of Little Texas Road at the corner of Clara Bell Robertson and running thence S 6-30 W 490.2 feet to an iron pin; thence N 86-06 W 278.5 feet to an iron pin; thence N 0-41 W 213.8 feet to an iron pin in the center of Little Texas Road; thence along the center of Little Texas Road the following courses and distances to-wit: N 76-45 E 85 feet; N 62-47 E 180 feet; N 31-21 E 178.7 feet to the point of beginning.

Said property is subject to a 12 foot driveway easement along the eastern side, adjacent to Robertson, 490.2 feet in length and 12 feet in width.

This is the same property conveyed to us by W.F. and Carolina H. Shivers in deed book 949, page 581 on July 21, 1972.
