WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of ____Thirty Tousand Eight Hundred and NO/100 DOLLARS

(\$ 30,800.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is -thirty- years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, situate on the southwestern side of Mimosa Drive (formerly New Mill Road in the City of Green, Chick Springs Township and being known and designated as all of LOTS 91 and 93 of the W. H. Brockman Estate according to a survey of record in the office of the RMC for Greenville County in Plat Book H at page 132, and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southwestern corner of the intersection of New Mill Road and Line Road (as shown on the above recorded plat, and proceeding thence with Line Road S. 38-10 W. 145 feet to an iron pin, joint corner of Lots 93 and 94; thence with the common line of said lots 108 feet to an iron pin; thence N. 16-20 W. 208.8 feet to an iron pin on New Mill Road; thence with New Mill Road 183.7 feet to the point of beginning, subject to roadways, easements, rights of way and zoning ordnances.

In addition to and together with the monthly payments of principal and interest under the terms of the note secured hereby, the nortgagor promises to pay to the mortgagee for the term of the guaranty policy the sum of 1/48th of 1% of the original amount of this loan in payment of the mortgage guaranty insurance covering this loan and on his failure to pay it, the mortgagee may advance it for the mortgagor's amount and collect it as part of the debt secured by the mortgage.

The mortgagors agree to maintain guaranty insurance in force until the loan balance reaches 75% or less of the original appraisal or sales price, whichever is less, and the mortgagee may apply for mortgage guaranty insurance to comply with the above, through the mortgage guaranty insurance company insuring this loan, and that the mortgager agrees to pay to the mortgagee, annually, as premium for such insurance 1/4 of 1% of the principal balance then existing.
