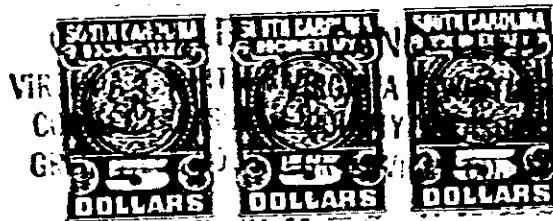

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, at the southwestern intersection of Cannon Lane & Randy Drive, being shown as Lot 34 on plat of Section II of Edwards Forest recorded in plat book RR at page 20 in the RMC Office for Greenville County, and having the following metes and bounds, courses and distances, to-wit:

Beginning at an iron pin on the westerly side of Randy Drive, joint front corner of Lots 33 & 34, and running thence with the line of said lots, S. 67-28 W. 200 feet to an iron pin; thence N. 22-32 W. 129.4 feet to an iron pin on the southerly side of Cannon Lane; thence with the southerly side of Cannon Lane, N. 53-03 E. 205.7 feet to an iron pin at the intersection of Cannon Lane and Randy Drive; thence with the westerly side of Randy Drive, S. 22-32 E. 180.7 feet to the point of beginning.
