WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Thirty-one Thousand and 00/100-----DOLLARS

(\$31,000.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 25 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Town of Mauldin, known and designated as lot 26 on a plat of Section No. IV, Knollwood Heights, plat of which is recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book 4N at Page 74 and having, according to said plat, the following metes and bounds:

BEGINNING at a point on the southeastern edge of Kingsley Drive at the joint front corner of lots 25 and 26 and running thence along a line of lot 26 S. 16-31 E. 227.1 feet to a point; thence along a line of Sunset Heights S. 73-27 W. 110.0 feet to a point; thence along a line of lot 27 N. 16-31 W. 209.7 feet to a point on the southeastern edge of Kingsley Drive; thence along the southeastern edge of Kingsley Drive N. 66-27 E. 44.1 feet to a point; thence continuing along the edge of Kingsley Drive N. 61-57 E. 46.5 feet to a point; thence continuing along the edge of said drive N. 67-54 E. 25.7 feet to the beginning corner, and being the same property conveyed by George O'Shields Builders, Inc. to Kathryn R. McCormick and John D. McCormick by a deed dated August 2, 1976, and recorded in the R.M.C. Office for Greenville County, South Carolina, herewith.
