"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Chick Springs Township, being shown and designated as Lot 21 on plat of Rosedale, recorded in Plat Book YY, at Page 35, in the R.M.C. Office for Greenville County, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Western side of Ivanhoe Circle at the corner of Lot No. 20; thence with line of said lot, N. 73-52 W. 130-feet to an iron pin on line of Lot No. 19; thence with line of said lot, S. 16-08 W. 50-feet to a stake; thence N. 73-52 W. 110-feet to an iron pin; thence S. 15-43 E. 191.3-feet to an iron pin; thence N. 72-40 E. 200-feet to an iron pin on said Circle; thence with said Circle, N. 6-24 W. 56.5-feet to a stake; thence with said Circle, N. 8-58 E. 49.9-feet to beginning corner.
