RELEASE FROM MORTGAGE

BEGINNING at an old iron pin at the joint corner of the tract herein described and property belonging now or formerly to Lincoln Properties, and running thence N 03-27 W 50.08 feet to a new iron pin; thence S 89-53 W 160.0 feet to a point; thence S 00-18 W 50.0 feet to an old iron pin; thence N 89-53 E 163.28 feet to an old iron pin, the point and place of beginning. ALSO:

An irregularly shaped parcel containing approximately 0.18 acre, lying to the immediate East of the 0.56 acre tract hereinafter described and having the following metes and bounds:
