MORTGAGE OF REAL ESTATE

WHEREAS, the Mortgagor is well and truly indebted unto FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, SOUTH CAROLINA (hereinafter referred to as Mortgagee) in the full and just sum of

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northwestern side of Flora Avenue, being shown and designated as Lot No. 52 on Map No. 2 of Camilla Park, made by W. J. Riddle, Surveyor, dated December, 1943, and recorded in the RMC Office for Greenville County in Plat Book M, page 85, and having, according to said plat, the following metes and bounds, to-wit:
