All that piece, parcel or lot of land in the City of Greenville, County of Greenville, State of South Carolina, known and designated as Lot No. 30 of ALTA VISTA according to a plat by R. E. Dalton, Surveyor, and recorded in Plat Book G, page 20 of the R.M.C. Office for Greenville County, and having the following metes and bounds, to-wit:
