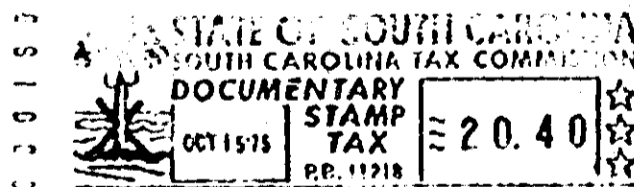

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown as Lot 92 on a plat map No. 3, Foxcroft, Section I, recorded in Plat Book 4-F at Page 4 in the RMC Office for Greenville County and having according to said plat the following metes and bounds:

Beginning at an iron pin on the eastern side of Stonehedge Drive, at the joint front corner of Lot 81 and lot 92, and running thence with the joint line of said lots N. 86-44 E. 250.6 feet to an iron pin; thence along the rear line of lot 92 S. 19-50 W. 180 feet to an iron pin; thence along the joint line of lot 92 & Lot 91 N. 79-41 W. 196.5 feet to an iron pin on the eastern side of Stonehedge Drive; thence with the eastern side of Stonehedge Drive N. 5-32 E. 54 feet to a point; thence N. 0-20 W. 54 feet to a point; thence N. 3-16 W. 12 feet to the point of beginning.
