(1) That this mortgage shall secure the Mortgagee for such further sums as may be advanced hereafter, at the option of the Mortgage, for the payment of taxes, Insurance premiums, public assessments, repairs or other purposes pursuant to the covenants herein. (6) That if there is a default in any of the terms, conditions, or covenants of this mortgage, or of the mote secured hereby, then, at the option of the Mortgagee, all sums then owing by the Moragagorto the Mortgagee shall become immediately due and payable, and this mortgage may be foreclosed.
