Now, Know All Men, that Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, assigned, and released, and by these presents does grant, bargain, sell, assign, and release unto the Mortgagee, its successors and assigns, the following-described property situated in the county of GReenville State of South Carolina;

All those certain pieces, parcels or lots of land, with all improvements thereon, situate, lying, and being in the State of South Carolina, County of Greenville, being known and designated as Lot \$136 and part of Lot \$135 on plat of "Addition to Greenbriar" recorded in the RMC Office for Greenville County in Plat Book AAA at page 61 and a recent survey entitled "Property of Jerry Janoski, Jr. and Martha Jane Janoski," dated May 4, 1971, prepared by Carolina Surveying Co. and recorded in Plat Book4-I at page 173 in the RMC Office for Greenville County, SC and having, according to said plats the following metes and bounds to-wit:
