"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, containing 6 acres according to plat entitled "Tom Bruce" prepared by Carolina Surveying Co. dated September 21, 1976 to be recorded herewith and having, according to said plat, the following metes and bounds, to-wit:

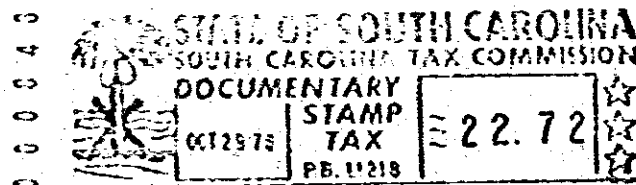
