All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown and designated as Lot #64 on plat of Eastgate Village Subdivision dated 5/15/73 and recorded inthe RMC Office for Greenville County in Plat Book 4X at Page 31. According to said plat, the property is more fully described as follows:
