"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

All that piece, parcel or lot of land, situate, lying and being on the Southern side of Chapman Road in the County of Greenville, State of South Carolina, being shown and designated as Lot No. 149, Chanticleer, Section IV, plat of which is recorded in the RMC Office for Greenville County in Plat Book 4F, Page 19, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southern side of Chapman Road at the joint front corner of Lots 149 and 150 and running thence with the joint line of said lots, S. 36-57 W. 140 feet to an iron pin; thence N. 61-32 W. 150 feet to an iron pin; thenceN. 38-05 E. 165 feet to an iron pin on the Southern side of Chapman Road; thence with the right of way of Chapman Road, S. 51-55 E. 145 feet to the point of beginning.
