TO ALL WHOM THESE PRESENTS MAY CONCERN: WE, ROBERT LUDWIG AND SUZANNE M. JUNGHANNS

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of TWENTY THREE THOUSAND, TWO HUNDRED FIFTY AND NO/100 ----- DOLLARS

(\$ 23,250.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 25 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

*All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

ALL that piece, parcel or lot of land, together with all buildings and improvements, situate, lying and being on the southeastern side of Cope Circle, in Greenville County, South Carolina, being shown and designated as Lot No. 14 on a final plat of COPE HEIGHTS made by J. C. Hill, RLS, dated December 1, 1962, recorded in the R. M. C. Office for Greenville County, S.C., in Plat Book III, page 103, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Cope Circle at the joint front corners of Lots Nos. 14 and 15, and running thence with the common line of said lots, S. 25-05 E., 150 feet to an iron pin; thence along the rear line of Lots Nos. 19 and 20, N. 64-55 W., 123 feet to an iron pin on the eastern side of Cope Circle; thence with Cope Circle and following the curvature thereof the following courses and distances, to-wit: N. 12-35 W., 103.4 feet to an iron pin; N. 26 E., 77.2 feet to an iron pin, and S. 64-55 E., 41.2 feet to an iron pin, the point of BEGINNING.

In addition to and together with the monthly payments of principal and interest under the terms of the note secured hereby, the mortgagor promises to pay to the mortgagee for the term of the guaranty policy the sum of 1/48th of 1% of the original amount of this loan in payment of the mortgage guaranty insurance covering this loan and on his failure to pay it, the mortgagee may advance it for the mortgagor's amount and collect it as part of the debt secured by the mortgage.

The mortgagors agree to maintain guaranty insurance in force until the loan balance reaches 75% or less of the (continued on page 4 hereof) Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
