MORTGAGE OF REAL ESTATE

WHEREAS. Leroy J. Davis, Jr. and Barbara J. Davis

(hereinafter referred to as Mortgagor) is well and truly indebted unto C N Mortgages, Inc.

In Sixty (60) monthly installments of One Hundred Twenty-three and no/100 (\$123.00) Dollars, beginning November 27, 1976, with the final payment due October 27, 1981.

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledge, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on then or thern side of Stonelake Drive being known and designated as Lot No. 32 on a plat of Section 3 of Stonelake Heights Subdivision prepared by Piedmont Engineering Services dated October 1, 1958, and revised on May 26, 1961, and is recorded in the RMC Office for Greenville County in Plat Book QQ at Page 96 and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the northern side of Stonelake Drive at the joint front corner of Lots 31 and 32 and running thence with the joint line of said lots N. 20-44 E., 167.7 feet to an iron pin; thence S. 69-16 E., 352.5 feet to an iron pin at the joint corner of Lots 32 and 33 on the northwestern edge of a Duke Power right-of-way and running thence with the joint line of Lots 32 and 33 along the northwestern edge of the Duke Power right-of-way S. 73-10 W., 265.5 feet to an iron pin on the northern side of Stonelake Drive and running thence with the northern side of said drive N. 71-29 W., 142.4 feet to an iron pin, the point of beginning.

This mortgage is junior in lien to that certain real estate mortgage dated February 22, 1960, and recorded in the RMC Office for Greenville County in Volume 817 of Real Estate Mortgages at Page 47.

This is the same property conveyed to the mortgagor herein by deed of Jacqueline A. Hardin and recorded in Deed Book 981 at Page 494, on August 13, 1973.

Together with all and singular rights, members, hereditaments, and appurtenances to the same belonging in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.

TO HAVE AND TO HOLD, ali and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided herein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagoe forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.

The Mortgagor further covenants and agrees as follows:

- (1) That this mortgage shall secure the Mortgagee for such further sums as may be advanced hereafter, at the option of the Mortgagee, for the payment of taxes, insurance premiums, public assessments, repairs or other purposes pursuant to the covenants herein. This mortgage shall also secure the Mortgagee for any further loans, advances, readvances or credits that may be made hereafter to the Mortgager by the Mortgagee so long as the total indebtness thus secured does not exceed the original amount shown on the face hereof. All sums so advanced shall bear interest at the same rate as the mortgage debt and shall be payable on demand of the Mortgagee unless otherwise provided in writing.
- (2) That it will keep the improvements now existing or hereafter erected on the mortgaged property insured as may be required from time to time by the Mortgagee against loss by fire and any other hazards specified by Mortgagee, in an amount not less than the mortgage debt, or in such amounts as may be required by the Mortgagee, and in companies acceptable to it, and that all such policies and renewals thereof shall be held by the Mortgagee, and have attached thereto loss payable clauses in favor of, and in form acceptable to the Mortgagee, and that it will pay all premiums therefor when due; and that it does hereby assign to the Mortgagee the proceeds of any policy insuring the mortgaged premises and does hereby authorize each insurance company concerned to make payment for a loss directly to the Mortgagee, to the extent of the balance owing on the Mortgage debt, whether due or not.
- (3) That it will keep all improvements now existing or hereafter erected in good repair, and, in the case of a construction loan, that it will continue construction until completion without interruption, and should it fail to do so, the Mortgagee may, at its option, enter upon said premises, make whatever repairs are necessary, including the completion of any construction work underway, and charge the expenses for such repairs or the completion of such construction to the mortgage debt.
