payments of \$371.12 beginning Decemberals, 1976



All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, City of Greenville, being shown and designated as a portion of Lots 29 and 30 on plat entitled "Portion of Paramount Park" by Campbell and Clarkson dated July 16, 1971, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the southeastern side of South Pleasantburg Drive, which iron pin is located a distance of 25 feet S. 46-41 W. from the northeastern corner of Lot 31, Paramount Park Subdivision: thencefrom said point of beginning running with the right-of-way of South Pleasantburg Drive S. 46-41 W. 100 feet to an iron pin; thence S. 43-15 E. 126 feet to an iron pin in the line of Lot 40; thence N. 46-45 E. 100 feet to an iron pin in the line of Lot 39; thence N. 43-15 W. 126.07 feet to an iron pin on the southeastern side of South Pleasantburg Drive at the point of beginning.
