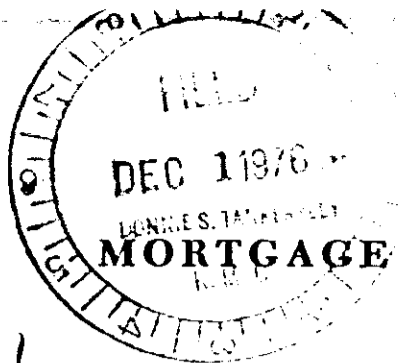

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the eastern side of Chateau Drive, being known and designated as Lot No. 35 on a plat of Merrifield Park, Section I, made by C. O. Riddle, Surveyor, dated October 1967, recorded in the RMC Office for Greenville County, S. C., in Plat Book 000, Page 177, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Chateau Drive at the joint front corner of Lots Nos. 35 and 36 and running thence with the common line of said lots, S. 88-20 E., 184 feet to an iron pin; thence N. 20-38 E. 116.3 feet to an iron pin at the joint corner of Lots Nos. 34 and 35; thence with the common line of said lots, N. 88-20 W., 221.9 feet to an iron pin on the eastern side of Chateau Drive; thence with the eastern side of Chateau Drive, S. 1-40 W., 110 feet to an iron pin, the point of beginning.
