WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of FIFTY-EIGHT THOUSAND AND NO/100-----DOLLARS

~~ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situated, lying and being in the State of South Carolina, County of Greenville,~~

ALL that certain piece, parcel or lot of land with the buildings and improvements thereon, lying and being on the southeasterly side of White Water Court, near the City of Greenville, S. C., being known and designated as Lot No. 177 on plat entitled "Map No. 2, Section 1, Sugar Creek" as recorded in the RMC Office for Greenville County, S. C. in Plat Book 4R, page 85 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southeasterly side of White Water Court, said pin being the joint front corner of Lots 177 and 178 and running thence along the common line of said lots S. 32-18-13 E. 137.51 feet to an iron pin, joint rear corner of Lots 177 and 178; turning and running thence S. 61-17-15 W. 106.89 feet to an iron pin, joint rear corner of Lots 176 and 177; running thence along the common line of said lots N. 29-24-40 W. 133.03 feet to an iron pin on the southeasterly side of White Water Court, said pin being the joint front corner of Lots 176 and 177; running thence along the southeasterly side of White Water Court N. 59-08-33 E. 81.21 feet to an iron pin; thence continuing along said Court N. 57-41-47 E. 18.79 feet to an iron pin, the point of beginning.
