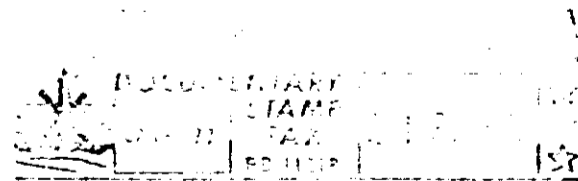

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

All that piece, parcel or lot of land lying in the State of South Carolina, County of Greenville, shown as Lot 69 on plat of Cedar Vale, Section Two, recorded in Plat Book 4 F at page 12 and having the following courses and distances as shown on said plat:

BEGINNING at an iron pin on Overton Avenue, joint front corner of Lots 68 and 69 and running thence with joint line of said lots, N. 23-18 E. 168.4 feet to an iron pin, joint rear corner of said lots; thence along the rear line of Lot 69, N. 67-02 W. 108 feet to an iron pin, joint rear corner of Lots 69 and 70; thence with joint line of said lots, S. 23-41 W. 178.6 feet to an iron pin on Overton; thence S. 75-41 E. 69.7 feet and S. 66-41 E. 40.3 feet to the point of beginning.
