January 1, 1987, and

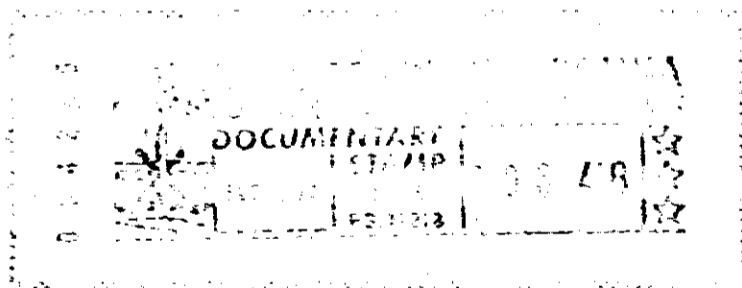
