(\$ 4,943.39----- ), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is eight years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

\*All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

All that piece, parcel or lot of land lying in the State of South Carolina, County of Greenville, shown as Lot 33 on plat of Greenfields, Section #4, recorded in Plat Book II at page 57 and having according to said plat the following courses and distances:

BEGINNING at an iron pin on Bonito Drive, joint front corner of Lots 33 and 32 and running thence with joint line of said lots, S. 21-32 E. 82.7 feet to an iron pin at joint rear corner of said lots; thence along rear line of Lot 33, S. 88-19 E. 94.6 feet to an iron pin on Air Base Road; thence with said Road, N. 0-56 W. 105 feet to iron pin in curve or said road with Bonito Drive; thence with said curve, S. 6-09 W. 22.8 feet to an iron pin on Bonito Drive; thence along said Drive, S. 68-28 W. 112.3 feet to the point of beginning.
