WHEREAS, we the said Russell C. Huttenstine and Blaine R. Huttenstine in and by our certain promissory note in writing of even date with these Presents, are well and truly indebted unto the CITIZENS BUILDING AND LOAN ASSOCIATION, Greer, S. C., in the full and just sum of
