

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Southwestern side of Verner Drive, being shown and designated as Lot No. 20 on a plat of Cedar Vale made by Piedmont Engineers & Architects, dated March 24, 1966, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book OOO, at Page 13, and being more particularly described according to a plat of Addition to (revision) of Cedar Vale made by Piedmont Engineers & Architects, dated February, 1968, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book WWW, at Page 11, as Lot No. 20 and an ajacent parcel of land which had prior to said revision comprised together the original Lot No. 20 of Cedar Vale, and having according to said plat the following metes and bounds, to-wit:
