NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the eastern side of Cane Creek Court, and being shown and designated as Lot No. 85 on Plat entitled GRAY FOX RUN, prepared by C.O. Riddle, dated August 6, 1975, recorded in the RMC Office for Greenville County, S.C. in Plat book 5-P, at Page 9, and having according to said Plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Cane Creek Court at the joint front corner of Lots Nos. 85 and 86 and running thence with the common line of said Lots N. 78-20 E. 133.1 feet to an iron pin; thence S. 13-53 E., 112.9 feet to an iron pin; thence with line of Lot 83 S. 76-07 W., 94.2 feet; thence with the line of Lot 84 N. 70-00 W. 120.6 feet to an iron pin on the eastern side of Cane Creek Court; thence with the curve of Cane Creek Court N. 36-29 E., 79.5 feet to the point of beginning. This is the same property conveyed to Mortgagors herein by deed from Threat-Maxwell Enterprises, Inc., recorded herewith.

In addition to and together with the monthly payments of principal and interest under the terms of the note secured hereby, the mortgagor promises to pay to the mortgagee for the term of the guaranty policy the sum of 1/48th of 1% of the original amount of this loan in payment of the mortgage guaranty insurance covering this loan and on his failure to pay it, the mortgagee may advance it for the mortgagors amount and collect it as part of the debt secured by the mortgage.

The mortgagors agree to maintain guaranty insurance in force until the loan balance reaches 80% or less of the original appraisal or sales price, whichever is less, and the mortgagee may apply for mortgage guaranty insurance to comply with the above, through the mortgage guaranty insurance company insuring this loan, and that the mortgagors agree to pay to the mortgagee, annually, as premium for such insurance 1/4 of 1% of the principal balance then existing.
