(a.4330) (2.40) do hereby agree to pay all taxes and other public assessments against this AND property on or before the first day of January of each calendar year, and to exhibit the tax receipts at the office of the CITIZENS BUILDING AND LOAN ASSOCIATION, Greer, S.
