"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, City of Greenville, on the western side of Keith Drive as shown by plat entitled "Property of Mildred A. Barton" made by C. C. Jones, Eng., on February 5, 1953 and recorded in the RMC Office for Greenville County in Plat Book DD, at page 35, and having, according to said plat, the following metes and bounds, to-wit:
