WHEREAS, the Mortgagor is well and truly indebted unto CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, Greenville, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of

DOLLARS (\$ 36,400.00), with interest thereon as provided in said promissory note, said principal and interest to be paid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 21, DEVENGER PLACE, SECTION 7, as shown on plat thereof prepared by Dalton & Neves Co., Engineers, dated September, 1975, which plat is of record in the RMC office for Greenville County, S. C., in Plat Book 5-P, at Page 3, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin in the Norther side of Richfield Terrace at the joint front corner of Lots Nos. 21 and 20, and running thence with the joint line of said lots, N. 3-49 W., 150 feet to an iron pin, joint rear corner of said lots; running thence with the rear line of Lot No. 21, S. 86-11 E., 90 feet to an iron pin, joint rear corner of Lots 21 and 22; running thence with the joint line of said lots, S. 3-49 E., 150 feet to an iron pin in Richfield Terrace, joint front corners of Lots Nos. 22 and 21; running thence with the Northern side of Richfield Terrace, N. 86-11 E., 90 feet to an iron pin, point and place of beginning.
