entry of a sudement enforcing this Mortgage if: all Borrower pays Lender all sums which would be then due under this Mortgage, the Note and notes securing Future Advances, if any, had no acceleration occurred. Borrower cores all boaches or asy the covenants or agreements of Borrower contained in this Mortgage, or Borrower pays all mass nable expenses incurred by Lender in enforcing the expenses and agreements of Borrower contained in this Mortgage and in enforcing Lender's remedies as provided in paragraph 18 hereof, including, but not limited to, reasonable attorney's feest and (d) Borrower takes such action as Lender may reasonably require to assure that the lien of this Mortgage, Lender's interest in the Property and Borrower's obligation to pay the sums secured by this Mortgage shall continue unimpaired.
