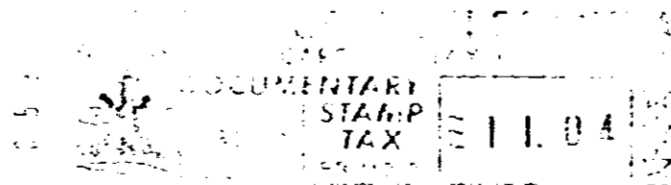
NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, lying on the south side of the Ballenger Taylor Road, about two miles north from the City of Greer, and being shown and designated as Lot No. 1 on a plat of the property of W. Dennis Smith, prepared by H. S. Brockman, Registered Surveyor, and dated July 29, 1952, said plat being recorded in Plat Book "T" at Page 452 in the R. M. C. Office for Greenville County, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southerly side of Ballenger Road and running thence S. 85-12 E. 190 feet to an iron pin; running thence S. 19-45 E. 200 feet to an iron pin, running thence N. 85-12 W. 190 feet to an iron pin; running thence N. 19-45 W. 200 feet to the point of BEGINNING.
