## MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN:

Louvenia Griggs and Larry B. Brownlee

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of

Thirty-One Thousand Two Hundred and No/100----- DOLLARS

(\$ 31,200.00 ), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 30 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on Great Glen Road being known and designated as Lot No. 45 on a plat entitled "Revision of Lots 45 and 46, Del Norte Estates, Section I," as recorded in Plat Book 4-K at Page 197 in the RMC Office for Greenville County, South Carolina, and having, according to said plat, the following metes and bounds:

BEGINNING AT an iron pin on the Northern side of Great Glen Road at the joint front corner of Lots 44 and 45, running thence with the joint line of said two lots, N. 13-00 W. 167.1 feet to an iron pin in Brushy Creek; thence along said creek, the creek being the line, N. 89-06 E. 118.2 feet to a point; thence N. 79-02 E. 77.0 feet to a point; thence S. 86-25 E. 18.75 feet to an iron pin at the joint rear corner of Lots 45 and 46; thence along the common line of said two lots, S. 27-11 W. 218.5 feet to an iron pin on the Northern side of Great Glen Road; thence along the Northern side of Great Glen Road N. 48-43 W. 19.7 feet to an iron pin; thence continuing along Great Glen Road, N. 87-05 W. 60.3 feet to the point of beginning.
