WHEREAS, the unpaid balance of said debt or debts, if not sooner paid, shall be due and payable,

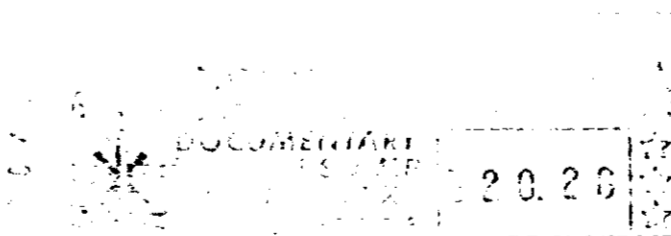

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being on the southeasterly side of White Water Court, near the City of Greenville, S. at an iron pin on the southeasterly side of White Water Court, said pin being the joint front corner of Lots 230 and 231 and running thence with the common line of said lots S 54-44-30 E 164.46 feet to an iron pin, the joint rear corner of Lots 230 and 231; thence N 56-26-55 E 85.57 feet to an iron pin; thence N 23-28-05 W 161.29 feet to an iron pin; thence S 74-49-17 W 80 feet to an iron pin on the easterly side of White Water Court; thence with the easterly side of White Water Court on a curve, the chord of which is S 30-39-29 W 71.74 feet to an iron pin; thence continuing on White Water Court on a curve, the chord of which is S 57-22-40 W 32.75 feet to an iron pin, the point of beginning.
