part thereof be placed in the hands of an attorney at law for collection by suit or otherwise, all costs and expenses incurred by the Mortgagee, and attorney's fees in the amount of 15% of the amount sued for, claimed or sought to be protected are hereby fixed; shall then become due and payable immediately or upon demand, at the option of the Mortgagee, as a part of the debt secured hereby, and may be recovered and collected hereunder.

- (7) That the Hortgagor shall hald and enjoy said premises above conveyed until there is a default under this mortgage or on the Note secured hereby. It is the true meaning of this instrument that if the Hortgagor shall perform all the terms, conditions and covenants of the mortgage, and of the Note secured hereby, then this mortgage shall be utterly null and void; otherwise to remain in full force and effect, with full virtue.
- (8) That the covenants herein shall bind, and the benefits and advantages shall inure to the respective heirs, executors, administrators, successors and asigns of the parties hereto.
