All that certain piece, parcel, or lot of land with all improvements thereon or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, lying and being on the easterly side of Greenwood Avenue, near the City of Greenville, South Carolina, and being designated as Lot No. 34 on plat of Hudson Acres as recorded in the RMC Office in Plat Book Y, page 39, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the easterly side of Greenwood Avenue, joint front corner of Lots 33 and 34 and running thence along the common line of said lots N. 84 E. 258.5 feet to an iron pin; thence N. 4-45 W. 198 feet to an iron pin, joint rear corner of Lots 34 and 35; thence along common line of said lots S. 84 W. 262.7 feet to an iron pin on the easterly side of Greenwood Avenue; thence along said Avenue S. 6-0 E. 200 feet to an iron pin, the point of beginning.
