ALL that piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, being shown as part of lots 35 and 39 and all of Lots 36, 37, and 38 on plat of Cuttino Heirs recorded in the RMCOffice for Greenville County, S. C. in Plat Book "J", page 121 and being shown on a more recent plat of Property of Betty C. Habighorst, prepared by R. B. Bruce, Surveyor, dated April 12, 1977, recorded in the RMC Office for Greenville County, S.C. in Plat Book 6-8, page 76 reference to said plat is hereby craved for the metes and bounds thereof.

The mortgagor covenants and agrees that so long as this mortgage and the said note secured hereby are guaranteed under the provisions of the Servicemen's Readjustment Act of 1944, as amended, he will not execute or file for record any instrument which imposes a restriction upon the sale or occupancy of the mortgaged property on the basis of race, color, or creed. INCLUDED in this mortgage is all carpet located on the above premises.
