WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of FOURTEEN THOUSAND, EIGHT HUNDRED & NO/100-------DOLLARS

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Green= ville, being situate on the northwestern side of McAdoo Avenue, being known and designated as Lot 83 on plat of Glenn Grove Park, recorded in Plat Book F at Page 233, and having the following metes and bounds according to said plat:

BEGINNING at an iron pin on the northwestern side of McAdoo Avenue, at the corner of Lot 84, and which point is 221.2 feet south of the Laurens Road and running thence with the line of McAdoo Avenue, S. 15-48 W. 50 feet to pin, corner of Lot 82; thence with the line of Lot 82, N. 74-12 W. 150 feet to pin; thence N. 15-48 E 50 feet to pin at corner of Lot 84; thence with the line of Lot 84, S. 74-12 E 150 feet to the beginning.
