"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, described as follows:

Being all of Lots Number Thirteen (13) and Fourteen (14) of Joe J. Gentry property as shown on plat made for Joe J.Gentry by J.Q.Bruce, R.L.S. October 13,1962 and recorded in R.M.C.Office for Greenville County. Reference is made to said plat for a more detailed description.

This is the same property deeded to Kenneth B.Pierce by deed dated April 9,1977, to be recorded herewith. This mortgage is given to secure a note given for purchase money, provided by W.L.Edwards Grantor.
