"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed the recn, situate, lying and being in the State of South Carolina, County of Greenville, near the City of Greenville, at the southeastern corner of the intersection of Williams Street and Piedmont Avenue as shown on a plat entitled "Property of William B. & Louise Compton", prepared by C. O. Riddle, R.L.S., dated April 8, 1977 and recorded in the R.M.C. Office for Greenville County, S.C. in Plat Book 6-B at Page 82, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southerly side of Piedmont Avenue which iron pin is 137.35 feet from an iron pin at the southeastern corner of the intersection of Piedmont Avenue and Williams Street, and also is joint corner of property to be retained by the Grantors, William B. & Louise Compton, and running thence S 13-44 W, 118.6 feet to an iron pin; thence N 76-46 W, 133.7 feet to an iron pin on the easterly side of Williams Street; thence along said street N 5-56 E, 105.7 feet to an iron pin; thence N 69-13 E, 13.4 feet to an iron pin; thence S 79-23 E, 137.35 feet to an iron pin, the point of beginning.
