WHEREAS, the Mortgagor is well and truly indebted unto **HERITAGE FEDERAL SAVINGS AND LOAN ASSOCIATION, LAURENS, S. NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of **Greenville, City of Greenville,** located in said City at the corner of James Street and David Street and being more particularly described as follows:

BEGINNING at the northwestern corner of James Street and David Street and running thence with James Street in a northeasterly direction 90 feet to a point; thence in a northwesterly direction 145 feet, more or less, to a point in the line of property now or formerly owned by Bruce; thence with the line of Bruce property 90 feet, more or less, to a point on the eastern side of David Street; thence with David Street in a southeasterly direction, 154 feet, more or less, to the point of beginning.
