"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereor situate, lying and being in the State of South Carolina, County of Greenville,

ALL that certain piece, parcel, or lot of land situate, lying, and being in Greenville County, South Carolina, being known and designated as Lot No. 1, containing 4.5 acres more or less on plat entitled "property of Ella Alberson" prepared by Clifford D.
