WHEREAS, the Mortgagor is well and truly indebted unto UNITED FEDERAL SAVINGS AND LOAN ASSOCIATION OF Fountain Inn, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of -----TWENTY THOUSAND & 00/100-----

DOLLARS (\$ 20,000.00 \_\_\_\_\_), with interest thereon from date at the rate of 8-3/4% per centum per annum, said principal and interest to be paid as therein stated, and

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Fairview Township, containing 2.61 acres, more or less, according to plat of Property of A. R. Wham by C. O. Riddle, Surveyor, dated February 1959, revised June 18, 1966, and having, according to said plat, the following metes and bounds, to wit:
