TO ALL WHOM THESE PRESENTS MAY CONCERN:

Arthur T. Siachos and Bessie A. Siachos

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Eighty Thousand and no/100----- DOLLARS

(\$ 80,000.00----), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is ten years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

*All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

All that piece, parcel or lot of land lying in the State of South Carolina, County of Greenville, City of Greenville, shown as Lots 1 and 2 on plat of Property of G. B. Lee, recorded in Plat Book K at page 43 and having the following courses and distances:

BEGINNING at an iron pin on Laurens Road at corner of Eastland Drive (formerly Buenavista Avenue) and running thence along Eastland Drive, N. 36-13 E. 170 feet to an iron pin; thence along the rear line of Lots 1 and 2, N. 55-26 E. 128.3 feet to an iron pin, joint rear corner of Lots 2 and 3; thence along joint line of said lots, S. 34-11 W. 169.6 feet to an iron pin on Laurens Road; thence along Laurens Road, N. 55-45 W. 134.7 feet, the point of beginning. This description includes a right of way to the S. C. State Highway Department due to the widening of Laurens Road.

Being the same property conveyed to the mortgagors herein by deed of Thomas M. Cowart, by deed recorded May 6, 1977.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
