TO ALL WHOM THESE PRESENTS MAY CONCERN: JOHN PERKINS and LORITA M.

PERKINS (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Sixty-four Thousand and no/100ths ----- DOLLARS

(\$ 64,000.00 ), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 30 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southern side of East Seven Oaks Drive, being shown and designated as Lot No. 83 on a plat entitled REVISED PLAT OF CHANTICLEER, made by R. K. Campbell, dated September 25, 1963, recorded in the RMC Office for Greenville County, S. C. in Plat Book EEE at page 79, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of East Seven Oaks Drive at the joint front corner of Lots Nos. 82 and 83 and running thence with the southern side of East Seven Oaks Drive, S. 82-22 E., 55 feet to an iron pin and N. 88-01 E., 55 feet to an iron pin; thence along the common line of Lots Nos. 83 and 84, S. 6-53 E., 223.4 feet to an iron pin; thence N. 7-33 W., 185 feet to an iron pin; thence along the common lines of Lots Nos. 82 and 83, N. 13-02 E., 173.3 feet to an iron pin, the point of beginning.

The above property is the same property conveyed to the mortgagors by deed of Chanticleer, Inc., recorded November 17, 1964, in Deed Book 761 at page 535.
