THIS MORTGAGE is made this 9th day of May, 1977, by and between the Mortgagor, NALLEY COMMERCIAL PROPERTIES, INC., P. O. Box 728, Easley, S. C. 29640, (herein "Borrower"), and the Mortgagee, UNITED FEDERAL SAVINGS AND LOAN ASSOCIATION, 201 Trade Street, Fountain Inn, S. C. 29644, (herein "Lender).

WHEREAS, Borrower is indebted to Lender in the principal sum of SIX HUNDRED THOUSAND & 00/100 (\$600,000.00) DOLLARS, which indebtedness is evidenced by Borrower's note, the terms of which are incorporated herein by reference, of even date herewith (herein "Note"), and providing for monthly installments of principal and interest with the balance of the indebtedness, if not sooner paid, due and payable on the 1st day of May, 1997.

To Secure to Lender (a) the repayment of the indebtedness evidenced by the Note, with interest thereon, the payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this Mortgage, and the performance of the covenants and agreements of Borrower herein contained, and (b) the repayment of any future advances, with interest thereon, made to Borrower by Lender pursuant to Paragraph 21 hereof (herein "Future Advances"), and also in consideration of the further sum of Three Dollars (\$3.00) to the Borrower in hand well and truly paid by the Lender at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, Borrower does hereby mortgage, grant and convey to Lender and Lender's successors and assigns the following described property located in the County of Greenville, State of South Carolina:

ALL that certain piece, parcel or tract of land, with all improvements thereon or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in or near the City of Greenville, as shown on plat entitled "Nalley Commercial Properties" prepared by Robert R. Spearman, R.L.S., on April 26, 1977, which plat is recorded in the R.M.C. Office for Greenville County in Plat Book 5// Page 2// , and having, according to said plat, the following metes and bounds, to wit:
