(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, Greenville, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Twenty-one Thousand and No/100-----

DOLLARS (\$ 21,000.00 ), with interest thereon as provided in said promissory note, said principal and interest to be paid as therein stated, and

All that certain piece, parcel or lot of land, situate, lying and being in the County of Greenville, State of South Carolina, being known and designated as Lot 89, Section 2, Wellington Green, on a plat thereof recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book YY at page 117 and having, according to said plat, the following metes and bounds:

BEGINNING at a point on the Northeastern side of Abingdon Way at the joint front corner of Lots 89 and 90 and running thence N. 57-45 W. 75 feet to an iron pin at the curve of the intersection of Abingdon Way and Kenilworth Drive, the chord of which is N. 11-04 W. 34.2 feet to an iron pin; thence along the Southeastern side of Kenilworth Drive N. 35-37 E. 145.1 feet to a point; thence along other property Jack E. Shaw Builders, Inc., S. 57-45 E. 90 feet to a point; thence along the line of Lot 90 S. 32-15 W. 170 feet to a point on the Northeastern side of Abingdon Way, the point of beginning.
