WHEREAS, the Mortgagor is well and truly indebted unto MORTGAGE CORPORATION OF THE SOUTH

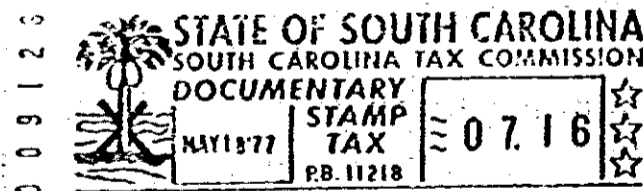

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its successors and assigns forever.
