TO ALL WHOM THESE PRESENTS MAY CONCERN:

WHEREAS, we, the said Richard Canada, Jr. and Frances Elizabeth P. Canada

(hereinafter referred to as Mortgagor) is well and truly indebted unto Pickensville Investment Company

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Three Thousand-Seven Hundred-Eighty and No/100's Dollars (\$ 3,780.00) due and payable

60 successive monthly payments of (\$63.00) Sixty Three and No/100's Dollars beginning May 25, 1977 and due on the 25th. of each and every month thereafter until the entire amount is paid in full

with interest thereon from ~~date~~ maturity at the rate of nine per centum per annum, to be paid: semi-annually

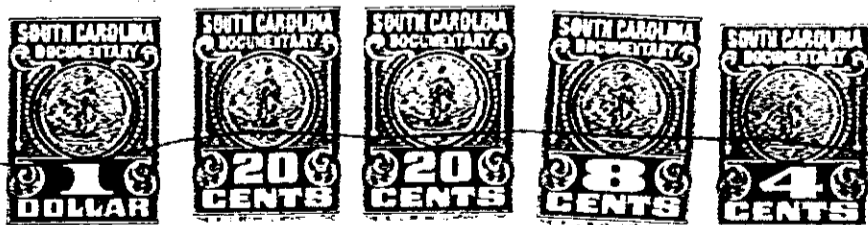
NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

ALL that piece, parcel, or lot of land in Greenville County, South Carolina and being in the City of Greenville on the southwestern side of Sitka Avenue and being known and designated as Lot Number 20 on plat of Park View in the RMC Office of Greenville County, South Carolina, in Plat Book M at page 49. According to said plat, the property is more fully described as follows:

BEGINNING at an iron pin on the southwestern side of Sitka Avenue at the joint front corner of lots 19 and 20 and running thence along said avenue N. 26-15 W. 50 feet to an iron pin; thence, along the joint line of lots 20 and 21 S. 63-45 W. 150 feet to iron pin on the northeastern side of Nicholtown Road; thence, with said road S. 26-15 E. 50 feet to an iron pin; thence, with the joint line of lots 19 and 20 N. 63-45 E. 150 feet to point of beginning.
