TO ALL WHOM THESE PRESENTS MAY CONCERN:

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Seven Thousand and no/100-----DOLLARS

(\$7,000.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is ten (10) years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

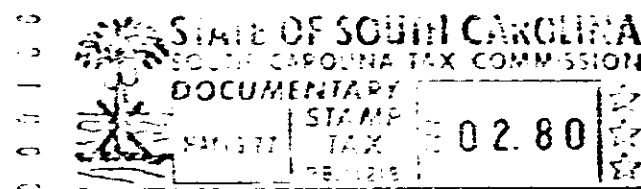
WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot 227 according to plat of Section A of the property of Woodfields, Inc., a subdivision located on the southwestern side of the Augusta Road, in the R. M. C. Office of the Greenville County Court House in Plat Book W at Page 75 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northwestern side of Fox Hall Road at the joint front corner of Lots 226 and 227 and running thence along the line of Lot 226 N. 60-42 W. 162.2 feet to an iron pin at the rear corner of Lot 226; thence S. 29-18 W. 50 feet to an iron pin at the rear corner of Lot 229; thence along the line of Lot No. 229 S. 15-42 E. 28.2 feet to an iron pin at the rear corner of Lot 228; thence along the line of Lot 228, S. 60-42 E. 147.1 feet to an iron pin on Fox Hall Road; thence along Fox Hall Road N. 25-54 E. 70.5 feet to an iron pin at the point of beginning.

This is the same property conveyed to the Mortgagor by deed of Hobert Calvin McDaniel recorded October 27, 1972 in Deed Book 959 at Page 50.



Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
