TO ALL WHOM THESE PRESENTS MAY CONCERN:

ANTHONY H. BROWN and VICKIE B. BROWN
(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of THIRTY-ONE THOUSAND FIVE HUNDRED AND NO/100-----DOLLARS

(\$ 31,500.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 30 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northerly side of Great Glen Road, being shown and designated as Lot No. 49 on a plat of DEL NORTE ESTATES, Sheet 1, made by Piedmont Engineers & Architects, dated August 28, 1968, recorded in the R.M.C. Office for Greenville County, S.C., in Plat Book WWW, at Page 32 and having, according to said plat, the following metes and bounds, to-wit:

➤BEGINNING at an iron pin on the Northerly side of Great Glen Road at the joint front corners of Lots Nos. 49 and 50 and running thence along the common line of said lots, N. 35-27 E. 134-feet to an iron pin; thence N. 75-19 W., 34.73-feet to an iron pin; thence N. 63-42 W., 57.26-feet to an iron pin at the joint rear corners of Lots Nos. 48 and 49; thence along the common line of said lots, S. 39-19 W., 132.3-feet to an iron pin on the northern side of Great Glen Road; thence along the Northern side of Great Glen Road, S. 62-58 E., 54.7-feet to an iron pin; thence continuing along said side of said Road, S. 69.25 E., 45.3-feet to an iron pin, the beginning corner.

This being the same property conveyed to the mortgagors herein by deed of even date herewith from Jerry H. Watson and Janice C. Watson recorded in the R.M.C. Office for Greenville County on June 22, 1972, in Deed Book 1238, at Page 297.

"In addition to and together with the monthly payments of principal and interest under the terms of the note secured hereby, the mortgagor promises to pay the mortgagee for the term of the guaranty policy the sum of 1/48th of 1% of the original amount of this loan in payment of the mortgage guaranty insurance covering this loan and on his failure to pay it, the mortgagee may advance it for the mortgagor's amount and collect it as part of the debt secured by the mortgage."
