TO ALL WHOM THESE PRESENTS MAY CONCERN: William M. Howle and Patricia

Ann F. Howle (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of

Sixty-two Thousand and No/100 ----- DOLLARS

(\$ 62,000.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is thirty years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown and designated as Lot Number 94 of Foxcroft, Section II, on plat of same recorded in Plat Book 4-N at Pages 36 and 37 of the RMC Office for Greenville County, and having according to said plat the following metes and bounds, to-wit:

BEGINNING AT AN IRON pin on Merrifield Court at the joint front corner of Lots 94 and 93 and running thence with the common line of said lots, N 3-01 E 186 feet to the joint rear corner of said lots; thence turning and running, N 74-59 W 121.3 feet to an iron pin at the joint rear corner of Lots 94, 84, 83 and 96; thence turning and running with the joint line of Lots 94 and 96, S 36-36 W 53 feet to a point at the joint rear corner of Lots 94 and 95; thence with the common line of said lots, S 7-46 E 180 feet to an iron pin on Merrifield Court, at the joint front corner of Lots 94 and 95; thence running with Merrifield Court, N 85-11 E 57.5 feet and continuing, N 88-55 E 57.5 feet to the point of beginning.
